November 10, 2014

The Horse Cave City Council met in regular session Monday, November 10, 2014, at 6:00 P.M. at City Hall. Present were Mayor Randall Curry and council members Vickie Rogers, Perry Martin, Ray Wilcoxson, Jackie Buckingham and David Lindsey. Council member Sue Nunn was out of town. Mayor Curry declared that a quorum was present and called the meeting to order.

Closing Main Street Parking – Mayor Curry reported that he had been approached by Judge/Executive Terry Martin and Scotty's Contracting representatives requesting that the city remove parking on one side of Main Street while construction continued on I-65 to allow for safe passage of asphalt trucks. He will again talk with these men to see if the problem can be resolved in any other way.

Citizen Concerns – There were no citizen concerns voiced.

Council Concerns – Perry Martin had reports from East Dale Heights and Dell Avenue about street and sidewalk problems. He will check and report back.

Vickie Rogers reported grooves on Walnut and Guthrie Streets and patches and ruts on Mill St. Street Committee chair Jackie Buckingham agreed to check on these streets.

Reports – Police, Fire and Maintenance presented their reports.

Mayor Curry announced that the Christmas Parade would be held December 6 at 10:00 A.M. the Deck the Hall store would open November 28. Work was continuing in the Maple Street Park.
