April 13, 2015

The Horse Cave City Council met in regular session Monday, April 13, 2015, at 6:00 P.M. at City Hall. - Jackie Buckingham expressed a need to blacktop the rear entrance drive to the Thomas House which is also now part of the Maple Ave Park walking trail.
- Jackie Buckingham had received concerns about the need for a fence or other appropriate landscape buffer around the City Maintenance Building.
- Vickie Rogers expressed a need for updating drainage across Mill Street between Water and Smith St.
